Consequently, many individuals with special needs and their loved ones may find it difficult to visit your facility due to the lack of restroom accommodations; hence, avoiding patronizing facilities such as yours.

We are seeking installation of a height adjustable adult-sized changing table and a hoist/lift. In an effort to partner with you in assisting our loved ones, I would like to provide you with a few benefits pertaining to these accommodations. The provision of an accessible restroom will:
